
## **EMPLOYMENT TRENDS**


Contrary to Todd County as a whole, the city of Long Prairie added employment from 2011-2016. Despite losing 37 jobs from 2015-2016, Long Prairie has 72 more jobs than it did in 2011. In the same period, Todd County has lost a net 24 jobs, but added 25 jobs in the last year. However, these changes are relatively small compared to employment trends statewide, which had employment growth of 8.1 percent from 2011-2016. (See Table 1).

The local difference in employment growth is evidently related to the recession of 2008-2009. Neither Todd County nor Long Prairie were affected nearly as much as the state as a whole, which suffered major employment loss during this period. However, since 2010 job growth rebounded statewide in a way that the local regions did not experience. During the recovery, the state added over 250,000 jobs while the local employment remained steady. (See Figure 1).

## **EMPLOYMENT BY INDUSTRY**

Employment changes in Long Prairie vary across several local industries. The majority of losses have been in Retail Trade, which decreased by 14 jobs last year and 26 since 2011. Other significant losses since 2011 have come from Information (-11 jobs), Education Services (-16 jobs) and Accommodation and Food Services (-13 jobs). On the other hand, the majority of employment gains have been in Manufacturing, which added 14 jobs last year and nearly 100 since 2011. Health care and Social Assistance also added 22 local jobs since 2011, despite losing seven jobs last year.

Overall, employers paid over \$114 million in wages in 2016. This equates to an average weekly wage of \$780 for employees who work in Long Prairie. Average weekly wages range from \$223 per week in Accommodation and Food Services to \$886 in Manufacturing. This includes all jobs, whether they are full-time, part-time, permanent or temporary. In comparison, the average weekly wages for all statewide jobs in 2016 was \$1,044, or over \$250 more than the average in Long Prairie. However, average weekly wages in Long Prairie were higher than that in both Todd County (\$702 per week) and EDR 5- North Central (\$693 per week).
