The Long Prairie City Council met by phone at City Hall, 7:00 pm, on Tuesday February 16th, 2021, Mayor Jodi Dixon called the meeting to order with the following present by phone or at City Hall: Council members, Lilah Gripne, Bob Klick, Datrick Mitchell, and City Administrator/Clerk Ted Gray. The council reviewed the proposed seal coating map for 2021. There were no additional roads added to the seal coating map.

Council member Dixon motioned Gripne seconded to approve tobacco license for Viva Tobacco & More LLC. Motion carried unanimously.

Council member Dixon motioned Mitchell seconded to approve the hiring of Matt Farrow and Dan Laumeyer for the Public Works department starting at a wage of \$19.64 an hour. Motion carried unanimously.

(Council Reports)

Police Safety: Fire Chief Dan Laumeyer gave a report. The Fire Department submitted for a FEMA Grant to purchase an extrication tool and cascade compressor for oxygen tank refills.

Census: Council member Gripne gave a report on the Census. The data may not be received until after March 1<sup>st</sup>.

Mayor Dixon gave a report. The Senior Center is now serving meals on Thursdays. The senior center is also looking to be open other days but is limited to just 2 hours at a time for patrons.
