# **LETTER from Bolten & Menk**

Hi Lu,

Thanks for sharing the Owatonna project. Looks like they spent a lot of time (and money) in developing their downtown plan over the course of several years and through several different projects, including a separate signage project.

As far as developing three different concepts, we can certainly do that for you. Can you provide an idea on how much public engagement and City staff engagement you are anticipating to develop these plans? Most of the time we start with an input process – this means getting feedback from a stakeholder group or steering committee, the general public, the Chamber of Commerce, City staff from multiple departments, etc. Then we develop concepts based on this. This all takes a little time.

Can you also let me know what kind of a budget you had in mind? Final production for the three ideas on the listed pages is not a real big lift, but the idea development and input sessions to get there does take a bit of time.

Here is a basic breakdown of the process, assuming good input sessions from the stakeholders:

- 1. Input session 1:
  - a. Base Mapping, research, and prep for meeting
  - b. Meeting with Stakeholders and documentation
- 2. Concept generation based on input session 1
- 3. Input session 2 (refining concepts)
- 4. Finalize concepts and construction costs

Prices and final product can be tailored to your budget, but there will be some time spent to get there.
